3.13 The proposal must be valid for at least ninety (90) calendar days after the proposal submission deadline (specified in the Letter of Invitation) (i.e. 20 September 2023). During the period of validity of their proposal or any agreed extension, the bidder is required to keep available the Key Personnel proposed for the Services.

#### **B5** SUBMISSION AND EVALUATION OF PROPOSALS

Please note the following amendment which increases the budget:

- 5.1 Bidders are required to submit a proposal to undertake this assignment under this Open procedure to provide research services, which shall include the following mandatory documents:
  - (i) Technical proposal in English in a non-editable format as a response to the Terms of Reference at Section E and as described in section F-1.
  - (ii) Financial Proposal in British Pounds Sterling and in a non-editable format detailing proposed inputs and rates for the proposed team and any reimbursable expenditure as described in section F-2. Bidders should note that the indicative budget is being increased to **GBP 250,000.00** for this assignment. Bidders must ensure that all rates and costs for reimbursable expenditure are rounded to two decimal places throughout their proposal. Failure to round all figures to two decimal places may result in the use of the whole number only for evaluation without any rounding.

#### B.6 COMMENCEMENT OF SERVICES

(iii) 6.1 The expected time for the commencement of the Services is approximately August 2023. The successful Research Supplier is expected to be available to commence the assignment during this month.
